


A heartfelt tribute





Community outreach

Three mobile clinics staffed by a doctor-driver-assistant team serve a population of about 160,000 in ~80 villages of district Sirohi.

This activity is called the Community Service Project. It targets an area that is underserved by the government health infrastructure.

Collectively, these clinics served 40,093 villagers during the year.




Rotary International Global Hospital Blood Bank

The Rotary International Global Hospital Blood Bank collected 6,965 units of blood from 6,568 male donors and 397 female donors.

Twenty six blood donation drives yielded 52% of these units while the remaining were collected within the premises.

The blood was processed into 14,545 units of whole blood, packed cells,

fresh frozen plasma, platelets and cryoprecipitate. 13,686 units of these were issued to 3,821 patients, 22% for free.

Community outreach

The main outreach activity was creating opportunities for people living in towns in the district and in neighbouring districts to consult the hospital's specialists at a venue near their residence.

Consultant orthopaedic & joint replacement surgeon Dr Nithin Sunku, physician Dr Sumeru Patil, resident medical officer Dr Prem Singh, senior clinical associate Dr Giriraj Sharma and dental surgeon Dr N S Girish made themselves available for such programmes, which were held in the premises of not-for-profits, schools, corporations and the North Western Railways.

Outreach activities also included training on subjects like cardiopulmonary resuscitation and diagnostic screening programmes such as for bone mineral density, hypertension and diabetes.

Case study

Laxmi Devi, age 42, lives in Udd Bhil Vas, Sirohi.

Laxmi became blind early in life. This caused her husband and two young sons much hardship. Her sons tried to help with the housework.

Poverty and ignorance kept Laxmi away from a medical facility... until Global Hospital organised an eye screening programme in her village.

Laxmi's neighbours urged her to consult the visiting team. She was found to have mature senile cataract in both her eyes. She could only sense hand motion in her right eye and perceive light in her left eye.

Laxmi was taken to the Global Hospital Institute of Ophthalmology for the operations and dropped back home. Her postoperative vision in both eyes was 6/18. With her vision restored, Laxmi felt as if she had gotten back her life.

Case study

Taga Ram, a 69-year-old resident of village Sutharo Ka Was, in block Rewat, Jalore, could count fingers up to a distance of three metres but could not see more. His vision was compromised by cataract in both of his eyes. His right eye was first operated on for no charges, after which he regained his sight (6/60). Taga Ram was very grateful for the service.





Vision Centres

Vision centres are small clinics/outposts providing eye checks and minor ophthalmic procedures, and referring more serious patients to the base hospital.

The trust runs five vision centres, attached to the Global Hospital Institute of Ophthalmology. These are located in Raniwada (district Jalore, since 2010), Kalandri (district Sirohi, since 2011), Pindwada (district Sirohi, since 2016), Reodar (district Sirohi, since 2022), and Sayla (district Jalore, since 2022).

The five centres collectively saw 8,602 out-patients, performed 5,494 refractions, prescribed 5,009 spectacles and dispensed 4,710 spectacles.

Health consultations numbered 850 and spanned general health, dermatology, gynaecology, orthopaedics and pulmonology.





Accreditation with the National Accreditation Board for Hospitals & Healthcare Providers

J Watumull Global Hospital & Research Centre achieved a significant milestone in June 2023, obtaining National Accreditation Board for Hospitals & Healthcare Providers (NABH) accreditation, valid through to May 31, 2027.

The accreditation is based on the 5th NABH edition standards comprising 10 chapters, 100 standards, and 651 objective elements. The elements are categorised into Core (102), Commitment (459), Achievement (60) and Excellence (30) levels.

The preparatory process saw the hospital implement 280 Standard Operating Procedures (SOPs)/policies, 35 clinical guidelines, 10 clinical procedures, an apex manual, drug formulary and other documents. Notably, the hospital has initiated an antibiotic stewardship programme to optimise the use of antibiotics, aligning with current healthcare best practices.

Risk management principles, particularly addressing risks identified through incident analysis, have been integrated into the hospital's operations. International Patient Safety Goals inform patient safety protocols and help minimise adverse events. To ensure continuous improvement, the hospital has created 12 committees dedicated to addressing issues, conducting root cause analysis (RCA) and implementing corrective and preventive actions (CAPA). Regular quarterly and bi-monthly interdepartmental audits further strengthen internal processes and operational efficiency.

Also, a comprehensive yearly training calendar is maintained, encompassing NABH sensitisation, infection control practices, occupational hazards and patient rights. These initiatives ensure that staff members are equipped with the necessary skills and knowledge to consistently deliver high-quality care.

During the term of the present accreditation, the hospital will undergo rigorous assessments to reaffirm its adherence to quality standards. In particular, the next surveillance inspections will evaluate the hospital's commitment to meet the Achievement and Excellence level standards. The hospital continues to engage in two quality improvement projects annually, reinforcing its commitment to advancing healthcare delivery and patient outcomes.

The state government / Mukhyamantri Ayushman Arogya Yojana

The Global Hospital & Research Centre trust partners the Government of Rajasthan to implement the Mukhyamantri Ayushman Arogya (MAA) Yojana, a statesponsored health insurance scheme for the poor. Beneficiaries are eligible for free treatment upto Rs 500.000 in affiliated hospitals. Both J Watumull **Global Hospital & Research** Centre and the Radha Mohan Mehrotra Global Trauma Centre are affiliated hospitals. At the former, 1,872 patients were admitted over the course of the year while 3,716 patients took benefit at the latter.

Case study

Sukiya Devi, age 47, had suffered from abdominal pain and swelling ever since she had undergone a hysterectomy and hernia repair five years ago. When her complaint suddenly increased in intensity, and she lost her appetite, she approached consultant general & laparoscopic surgeon Dr Kamal Joshi. Investigations showed that she had a hernia of the abdominal wall. Dr Joshi performed a right iliac fossa incision hernia repair with a preperitoneal meshplasty. Sukiya recovered very well.



The central government / National Tuberculosis Elimination Programme

India has the largest share of the global tuberculosis burden. Studies show that people with tuberculosis in rural India stay infectious for twice as long as infected people in urban India. So, speeding up the diagnosis and commencement of treatment of tuberculosis patients in rural India would help contain the spread of disease.

The Global Hospital & Research Centre trust partners the central government for the implementation of the National Tuberculosis Elimination Programme, previously called the Revised National Tuberculosis Control Programme, the country-wide initiative to reduce the burden of tuberculosis by 2025, five years ahead of the Sustainable Development Goals. The government partially reimburses the cost of diagnosing suspectpatients and monitoring confirmed patients through the course of treatment. The government also provides the WHO-prescribed medication for no charges.

Field workers attached to the Community Service Project implement this project. Last year, they collected 709 sputum samples, of which 172 tested positive. In all, 105 patients completed the treatment regimen, of whom 102 were declared tuberculosis free. 27 patients were referred. The field workers also distributed nutritional supplements to the patients to boost their immunity and reduce the chance of a relapse. Contributions from GiveIndia helped to cover this cost.

The central government / National Programme for Control of Blindness

J Watumull Global Hospital & Research Centre, Global Hospital Institute of Ophthalmology and the Shri Adinath Fateh Global Eye Hospital implement the National Programme for Control of Blindness, the central government's initiative to eradicate preventable blindness occurring from diseases like cataract. Government estimates suggest that thousands of people with mature cataracts in Rajasthan and other states need surgical intervention. To treat these people, the central government has partnered with private health providers like the Global Hospital & Research Centre trust.

Partners conduct screening programmes in villages to identify needy patients, provide them transport to the base hospital, operate on them and drop them back home. The government pays a part of the cost of such cataract operations. These activities have been separately reported under each unit.

Collectively, these units performed 923 operations on patients covered by the District Blindness Control Society Jalore and 1,105 operations on patients covered by the District Blindness Control Society Sirohi.

J Watumull Global Hospital & Research Centre has been enlisted as a treatment centre for beneficiaries of the Employees State Insurance Corporation (ESIC). Last year, 268 employees of commercial establishments claimed the cost of their treatment in the out-patient department, and 77 employees who were hospitalised claimed their treatment cost. Most beneficiaries of the ESIC are employees of hospitality establishments in the town.

J Watumull Global Hospital & Research Centre is also an empanelled private hospital to deliver allopathic and AYUSH medicare to former service personnel and their dependents, under the Ex-Servicemen Contributory Health Scheme (ECHS). Twelve patients were admitted in this category last year.

J Watumull Global Hospital & Research Centre is an empanelled hospital for the treatment of employees (stationed at Mt Abu) of the Central Reserve Police Force, Physical Research Laboratory, Bhabha Atomic Research Centre, Armed Forces, All India Radio, Central Public Works Department and Kendriya Vidyalaya.

Radha Mohan Mehrotra Global Hospital is enlisted as a private treatment provider for retirees and serving employees of the North Western Railways and their dependents. Last year, 305 retirees and 95 serving employees availed of the out-patient services while 102 retirees and 28 serving employees were admitted.
